5% of rental fees will be designated for facility improvements to comply with the American Disabilities Act.

General Information

- Areas may be rented one year in advance. Choice of a specific rental area is made upon a first-come-first-served basis.
- All deposits and fees are due and payable upon approval of application.
- All groups must pay a \$100 refundable security deposit. Deposits will be retained for damages or excessive clean up.
- Cancellations will be subject to a handling fee of 20% (minimum of \$10) of the total cost of the rental.
- Cancellations, less than 30 days before the event, will be charged the entire deposit plus 1/2 of the rental fee.
- Applicant is responsible for clean up of the area. Rental times must include set up and clean up.
- There may be other activities going on at the pool (except for private pool parties).
- All scheduled activities of Pleasant Hill Recreation & Park District have first priority in use of aquatic facilities.
- If required, certificate of insurance must be received two weeks prior to the event.
- No smoking or alcohol permitted in the pool/picnic areas.

Private Pool Parties: Minimum rental, 2-hour time slot, provides exclusive use of the diving pool, sprayground and picnic area. Sprayground only rentals are also available. Training pool requires \$30 additional fee. Extended use/hours are available upon request/availability. Hours:

Pool Picnics: Rentals are available during all public swim hours (one picnic site per rental). Fee includes use of one picnic area (1 BBQ and 2 tables) and an admission pass for 16 people. The admission charge for each additional person is \$10 with a maximum of 20 people.

Children's Birthday/Swim Parties: (6 years & up) A swim party with water games and prizes! Fee includes admission for 10 children and 4 adults, use of 2 picnic tables and 1 BBQ (swim lessons use one pool). Additional children are \$10 each & adults are \$5 each. Sprayground use requires \$50 additional fee.

HOURS: (3/29-11/2) Saturday & Sunday, 10:30am - 12:30pm

FEES: Residents \$130/10 children; Non-Residents \$150/10 children

College Park and Pleasant Hill Education Center Pools

FEES: \$850 per day includes the cost of one custodian and lifeguard from 7am-4pm (the fee for additional custodians is set by the school district). For hourly use (2 hour minimum), see the above private use rate. The school district may require applicant to pay for the cost of a dumpster at the event.

Group Rental for Persons With Disabilities

Times vary depending on pool availability. Groups may be required to provide one-on-one aides. Any personal flotation devices (PFD's) used by participants must be US Coast Guard approved and properly fitted. Additional fees (\$15 per hour) required for more than one lifeguard or use of more than one pool.
