2. Discuss and provide direction to staff regarding issues related to Chilpancingo Park:

 - Request by DVC Plaza Property Owners/Developers to place a temporary construction fence on Chilpancingo Park to facilitate redevelopment of the DVC Plaza Property
 - Proposal for long-term access to Chilpancingo Park from and through the DVC Plaza Property
