BATS:

MULTIPLE WALLED BATS ARE OUTLAWED IN ALL MEN'S, WOMEN'S AND CO-ED "D", "C/D" & "E" LEAGUES.

- This includes all double, triple, quadruple or additional walled bats. Any bats that have an interior or exterior wall/shell/casing/etc, a description that can be considered as more than one wall or is more than one piece construction are OUTLAWED in our "D" leagues.
- Players wishing to use multiple walled bats must play in one of our higher leagues (C).
- Buy your bats after the meeting, otherwise you may not be able to use your bat in our leagues.

ROSTERS/ROSTER CHANGES:

- Only players on the team's official roster may participate.
- Roster changes must be received at the District Office before 5:00 pm, Monday - Friday, prior to your game, using the League's "Addition Form" (field staff DO NOT handle roster additions/changes).
- An added player may not use a dropped player's non-resident fee after March 16.
